Sir,

I am directed by order of the Governor to say that the Governor has been pleased to sanction and allot a sum of **Rs. 286,45,23,000/- (Rupees two hundred eighty six crore forty five lakh and twenty three thousand)** only out of the administratively approved amount of **Rs. 287 Crore (Rupees two hundred eighty seven crore)** only to meet the expenditure to be incurred in connection with payment of Annual Scholarship @ **Rs. 500/- (Rupees five hundred)** only and One Time Grant @ **Rs. 25,000/- (Rupees twenty five thousand)** only to the beneficiaries under the scheme "Kanyashree Prakalpa" during the current financial year 2013-14, directly from the district to the beneficiaries' account subject to observance of usual rules and procedures.

The said amount of **Rs. 286,45,23,000/- (Rupees two hundred eighty six crore forty five lakh and twenty three thousand)** only is placed at the disposal of the Principal Secretary to G.T.A., Director of Social Welfare and 18 D.M.s of the State as detailed in the Annexure-I & II.

The charge will be debited to the Head of Account "2235-02-103-SP-026-V-31-02-Other Grants", "2235-02-789-SP-048-V-31-02-Other Grants" and "2235-02-796-SP-049-V-31-02-Other Grants" in the current financial year's State Budget 2013-14, under Demand No. 56, Departmental Code: SW in the manner mentioned in Annexure-I & II.
